# A QUALITATIVE EXAMINATION OF RELIGION'S INFLUENCE ON SOCIAL AND TECHNOLOGICAL PROGRESS

#### **Abstract**

Religion plays a significant role in shaping the social and technological architecture of societies, influencing values, behaviours, and development priorities. This paper examines the intersection of religion and technological development, focusing on how religious beliefs shape social structures and guide the adoption and integration of new technologies. The objectives are to investigate the influence of religious ideologies on technology-driven social development and to identify the opportunities and challenges posed by this interaction. A qualitative approach was employed, involving in-depth interviews with religious leaders, technology experts, and community members from diverse religious backgrounds in North Central, Nigeria. The findings reveal that religious values impact decision-making processes related to technological advancements, particularly in areas such as ethics, education, and governance. Religious communities that emphasize ethical considerations in technology tend to foster socially responsible innovation, while conservative interpretations may slow technological adoption. The discussion highlights the dual role of religion as both a facilitator and barrier to technological progress, depending on its alignment with innovation principles. The study concludes that incorporating religious perspectives into social and technological development frameworks can create more ethically grounded and inclusive societies. Recommendations include enhancing collaboration between religious leaders and policymakers, fostering dialogue on ethical technology use, and designing educational initiatives that integrate religious and technological literacy.

### Introduction

Religion has long been a cornerstone of human civilization, deeply influencing our cultural norms, societal structures, and even the trajectory of technological progress. In the context of North Central Nigeria, religion holds a significant place in shaping how individuals behave and how communities prioritize their collective goals, especially when it comes to adopting and developing new technologies. This paper delves into the intricate relationship between religion and technology in this region, examining how deeply held beliefs inform technological advancements and societal values. It also addresses the ethical considerations that come into play in areas such as governance, education, and innovation. By exploring these dynamics, the study aims to uncover how religious

ideologies influence technology-driven social development and to highlight both the challenges and opportunities that arise from this complex interplay.

The interplay between religion and societal development has garnered significant scholarly attention, particularly in the context of rapid technological advancement and evolving social structures. Understanding religion's role in shaping social dynamics and technological progress is crucial, especially as societies navigate the complexities of modernization and globalization. In recent decades, scholars have examined how religious beliefs inform moral frameworks, community values, and ethical considerations surrounding new technologies. For instance, José Casanova (2016) emphasizes the relevance of public religion in his work *The Secularization of the* European Union, asserting that religion actively engages with social and political realms rather than remaining confined to private spaces. Grace Davie (2015), in Religion in Britain: A Persistent Paradox, highlights the phenomenon of "believing without belonging," indicating that while traditional religious observance may decline, underlying belief systems continue to influence societal norms and behaviors. Moreover, Ammerman (2015) explores the adaptive nature of religious identities in Spiritual but Not Religious: Understanding Unchurched America, suggesting that individuals form communities around shared values outside of formal religious institutions. This adaptability is particularly relevant in the digital age, where technology mediates religious practices and fosters community engagement. Campbell (2012) addresses this in Digital Religion: Understanding Religious Practice in Digital Media, exploring how digital platforms have transformed religious expression and interaction. Additionally, the ethical implications of technological advancements necessitate a dialogue between religious perspectives and technological development. Langdon (2023) in The Whale and the Reactor advocates for a holistic ethical framework that incorporates diverse perspectives, including religious teachings, to address the moral dilemmas posed by technology. Recent discussions around artificial intelligence, biotechnology, and environmental sustainability highlight the need for religious ethical considerations to guide technological innovation, as exemplified by Pope Francis's encyclical Laudato Si': On Care for Our Common Home (2015), which calls for collaboration between religious institutions and technological innovators to address pressing global challenges. As such, this study aims to explore how various religious traditions influence social norms, ethical considerations, and technological progress, providing a qualitative examination of the lived experiences within religious communities and their responses to contemporary issues.

The complex relationship between religion, social structures, and technological advancement is a rich field of study that has gained prominence in recent years, particularly as societies grapple with the challenges and opportunities presented by globalization, digital communication, and rapid innovation. Religion has long served as a cornerstone of cultural identity, moral guidance, and community cohesion, influencing social norms and behaviors in profound ways. In the 21st century, the interaction between religion and technology has become increasingly multifaceted, raising important questions about the ethical implications of technological advancements and the ways in which religious communities adapt to changing social landscapes. Scholars such as Manuel (2024) have argued that the rise of the network society fundamentally alters the way religious communities operate, as digital platforms enable new forms of interaction and engagement. In *The Information Age: Economy, Society, and Culture*, Castells posits that technological developments facilitate the formation of virtual religious communities that transcend geographical boundaries, thereby reshaping traditional notions of faith and belonging.

Moreover, the emergence of digital media has transformed the dynamics of religious expression and practice. Campbell (2022) highlights in her seminal work, *Digital Religion: Understanding* 

Religious Practice in Digital Media, how online platforms have become vital spaces for religious discourse and community building, allowing diverse faith traditions to flourish in digital environments. This shift necessitates a reevaluation of how religious institutions communicate their values and engage with followers, particularly younger generations who are more likely to seek spiritual fulfillment through digital means. Campbell's research illustrates that while technology offers new avenues for religious engagement, it also presents challenges, such as the potential for fragmentation and the dilution of traditional beliefs. In addition to the transformative effects of digital technology, the ethical dilemmas posed by advancements in artificial intelligence, biotechnology, and data privacy have prompted renewed attention to the intersection of religion and ethics. As Nicholas Carr (2020) discusses in The Shallows: What the Internet Is Doing to Our Brains, the cognitive effects of digital technology may alter how individuals perceive their spirituality and moral responsibilities. This phenomenon calls for an urgent dialogue between technologists and religious leaders to ensure that ethical considerations are integrated into the development and implementation of new technologies. Langdon Winner (2023) advocates for a nuanced understanding of technology as a value-laden enterprise, suggesting that religious perspectives are essential for navigating the moral complexities of contemporary technological innovations.

The concept of environmental stewardship has also gained traction within religious communities, particularly in light of growing concerns about climate change and ecological degradation. Pope Francis's encyclical, *Laudato Si': On Care for Our Common Home* (2015), emphasizes the moral imperative for individuals and communities to address environmental issues through a lens of social justice and solidarity. This call to action exemplifies how religious teachings can inform ethical responses to technological challenges and promote sustainable practices. Scholars such as Gottlieb (2024) in *The Oxford Handbook of Religion and Ecology* highlight the rich resources within religious traditions that can guide ethical engagement with environmental concerns, further illustrating the potential for religion to play a vital role in shaping social and technological progress.

In examining the influence of religion on social and technological progress, it is also essential to consider the impact of religious pluralism in contemporary societies. The coexistence of diverse religious beliefs often leads to both conflict and collaboration, shaping social dynamics in significant ways. Research by Diana, (2020) in *A New Religious America* underscores the importance of interfaith dialogue and cooperation in addressing shared social challenges, suggesting that religious pluralism can foster greater understanding and community engagement. This diversity of thought and practice can inspire innovative approaches to social issues, as various faith traditions contribute their unique perspectives on ethics, justice, and the common good.

Furthermore, the increasing secularization of societies presents both challenges and opportunities for religious institutions. Grace Davie (2015) explores the implications of declining traditional religious observance in *Religion in Britain: A Persistent Paradox*, positing that while individuals may drift away from formal religious affiliations, their spiritual beliefs often persist and adapt to contemporary realities. This suggests that religious institutions must find new ways to engage with individuals seeking meaning and connection, leveraging both traditional teachings and modern platforms to reach broader audiences.

As this study aims to qualitatively examine the influence of religion on social and technological progress, it will draw upon these diverse perspectives to illuminate the lived experiences of individuals within religious communities. By exploring how various faith traditions navigate the challenges posed by technological advancements and social change, this research will contribute

to a deeper understanding of the interplay between belief systems, ethical considerations, and innovation in the modern world.

#### **Literature Review**

Religion and technology have historically had a complex relationship. Scholars note that religious ideologies significantly influence the reception and implementation of technological advancements, affecting areas such as educational priorities, ethical considerations, and governance (Adewole, 2019). The literature highlights two opposing trends: while some religious communities adopt a progressive stance, encouraging innovation that aligns with ethical values, others remain conservative, often wary of technologies perceived as challenging traditional beliefs (Taylor, 2020). This duality underlines the need to understand how religious perspectives either facilitate or inhibit technological progress, with implications for societies aiming to balance ethical considerations and innovation.

Religion and technology are two powerful forces that shape societal values and guide cultural development. The influence of religion on technological progress has been observed across societies and historical periods, where religious beliefs have been found to either support or resist technological advancements depending on their perceived impact on social and ethical norms (Smith, 2021). Literature reveals that religious communities often respond to technological advancements through a lens of ethical concern, focusing on whether these innovations align with moral values (Adewole, 2019).

In societies with significant religious influence, technological adoption may be encouraged when it aligns with ethical teachings and principles of social responsibility. Conversely, technologies that seem to threaten traditional beliefs or introduce values contradictory to religious norms may encounter resistance. Taylor (2020) notes that religiously conservative communities often display a cautious approach to technology, especially when it involves changes to family structure, privacy, and community dynamics.

Religious perspectives play a complex role in governance as well, influencing policymaking related to technology in ways that reflect ethical priorities grounded in religious values. In regions like North Central Nigeria, where religion strongly influences social and cultural life, the role of religious leaders is central to technology discourse, guiding community acceptance of innovations that align with shared beliefs (Akinbode, 2021). This complex dynamic reveals a need for frameworks that integrate religious views to foster inclusive technological development while respecting cultural and ethical values.

Religion and technology have historically maintained a multifaceted and sometimes contentious relationship, significantly shaping societal norms and influencing cultural development. Scholars have documented that religious ideologies play a pivotal role in determining how technological advancements are received and implemented across various contexts. For instance, they impact educational priorities, ethical considerations, and governance frameworks (Adewole, 2019). The literature reveals two contrasting trends in this relationship: on one hand, certain religious communities adopt a progressive stance, advocating for innovations that resonate with their ethical values and enhance societal welfare; on the other hand, more conservative factions remain skeptical, often viewing technological advancements as threats to traditional beliefs and practices (Taylor, 2020). This duality highlights the necessity for a nuanced understanding of how religious perspectives can either facilitate or inhibit technological progress, particularly in societies striving to balance ethical considerations with the demands of innovation.

Throughout history, the interplay between religion and technology has been observed across diverse cultures and periods, revealing a pattern in which religious beliefs both support and resist technological change based on perceived social and ethical implications (Smith, 2021). When technological innovations align with religious teachings on stewardship and social responsibility, they are typically embraced. In contrast, technologies perceived as disruptive—such as genetic modification or artificial intelligence—may face pushback from communities that prioritize maintaining traditional social structures and ethical norms. Taylor (2020) emphasizes that conservative religious groups often adopt a cautious approach to technological advancements, particularly when these innovations could alter family dynamics, privacy, or community cohesion. Recent studies have shown that the growing influence of technology on everyday life has intensified debates within religious communities, prompting a reevaluation of traditional beliefs in light of new ethical dilemmas posed by advancements in fields such as bioethics and data privacy (Garcia, 2023).

Moreover, religious perspectives significantly influence governance and policymaking, particularly in regions where religious authority is deeply intertwined with social and cultural life. In North Central Nigeria, for example, religious leaders play a crucial role in shaping the discourse around technology, guiding community acceptance and integration of innovations that align with collective beliefs (Akinbode, 2021). Recent findings indicate that in contexts where religious organizations actively participate in policy discussions, there is a greater likelihood of achieving consensus on technological issues, underscoring the importance of integrating religious viewpoints into policy frameworks (Brown, 2022). This relationship emphasizes the need for developing frameworks that consider religious perspectives in discussions about technological development, ensuring that ethical and cultural values are respected. Such frameworks can foster inclusive innovation, enabling societies to navigate the complexities of technological change while maintaining a commitment to the ethical principles rooted in their religious traditions. As societies continue to grapple with rapid technological advancements, understanding this intricate relationship becomes ever more critical for promoting both progress and social harmony.

## **Hindu Spirituality and Technology**

Bindlish and Nandram (2024) present a nuanced exploration of Hinduism's adaptability in the face of technological change, particularly within the context of a volatile, uncertain, complex, and ambiguous (VUCA) world. Their study, published in the *Encyclopedia of Diversity, Equity, Inclusion and Spirituality*, draws on historical, philosophical, and psychological frameworks to empirically demonstrate how Hindu thought systems accommodate and even ritualize technological innovation. At the heart of their findings is the principle of cognitive pluralism, which reflects Hinduism's acceptance of multiple truths, whether monotheistic, polytheistic, or even atheistic. This openness provides a flexible cognitive framework that allows adherents to incorporate digital tools into spiritual practice without ideological conflict, thereby fostering innovation and adaptability. The study also highlights how technology is understood as a sacred extension rather than a secular intrusion. Digital applications that support puja rituals, astrology consultations, or temple livestreams are embraced as legitimate instruments for dharmic living. In this sense, the digital is sacralized, becoming part of the continuum of spiritual life.

A third empirical finding emphasizes spiritual resilience in a VUCA world. Hindu spirituality equips practitioners with inner stability and ethical grounding, enabling them to navigate the uncertainties of digital disruption with purpose and mindfulness. Researchers further draw on a quantum cognition analogy, comparing Hindu philosophical thought to quantum physics where light exists simultaneously as wave and particle. This metaphor illustrates Hinduism's ease with paradox and complexity, which in turn supports an acceptance of technology as both material and

metaphysical. Finally, the study underscores the role of dharma as an ethical compass for digital engagement. Technology is not perceived solely as a functional tool but as a medium for fulfilling righteous duty, whether through spiritual growth, community service, or self-realization. This ethical framing encourages responsible, purposeful use of digital platforms. Together, these findings demonstrate that Hindu spirituality cultivates a distinctive approach to technology, one that ritualizes digital practices, embraces paradox, and grounds innovation in ethical and spiritual principles.

## **Digital Islam and Muslim Influencers**

Zaid et al. (2022) conducted a multiple case study examining how Muslim social media influencers in the Gulf region are reshaping religious authority and Islamic practices among millennial Muslims. The study analyzed content from four prominent influencers; Salama Mohamed, Khalid Al Ameri, Ahmad Al-Shugairi, and Omar Farooq using thematic analysis of their Instagram and YouTube posts. The study reveals several important empirical findings. First, it highlights the disruption of traditional authority, showing how Muslim influencers challenge clerical dominance by offering Islam in forms that resonate with contemporary audiences through storytelling, lifestyle branding, and civic engagement rather than rigid dogmatic instruction. Closely tied to this is the mediatization of religion, where digital platforms become central spaces for religious discourse, shifting the locus of authority away from established institutions and toward individual voices with broad online reach.

Another key finding concerns the emphasis on orthopraxy over orthodoxy. Here, conformity to Islam is increasingly expressed through practice, lived experience, and visible acts of devotion rather than strict doctrinal adherence. This orientation aligns closely with consumer culture, which values personalization, authenticity, and individual choice. The research also identifies the emergence of GUMmies (Global Urban Muslims), a generation of tech-savvy, cosmopolitan millennials who seek religious content that is both personalized and relatable. Their preferences reflect their lived realities and ethical concerns, underscoring a demand for religious narratives that speak directly to their daily lives. Finally, the study points to the rise of hybrid religious communication, where influencers skillfully blend entertainment with moral and spiritual messaging. Through polished media production, personal storytelling, and relatable narratives, they capture the attention of their audiences and redefine what religious authority looks like in a digital age.

## **Hybrid Faith and Digital Church Communication**

Dzirasa-Payne (2024) explores how churches adapted their communication strategies during the COVID-19 pandemic by integrating digital technologies into worship and pastoral care. The dissertation uses qualitative methods, including interviews with church leaders and congregants, to examine the emergence of hybrid faith practices in the U.S. and Ghanaian contexts. The study presents several significant empirical findings on the digital transformation of contemporary Christian worship. One of the most striking shifts is the digital transformation of worship, as churches swiftly embraced platforms such as Zoom, Facebook Live, and YouTube to host services, Bible studies, and prayer meetings. This development was more than a logistical adjustment; it reshaped both theological engagement and the dynamics of community life within congregations. Building on this, the study introduces the hybrid faith model, which reflects the coexistence of digital and physical expressions of worship. While congregants valued the flexibility and

accessibility of online services, many emphasized that in-person gatherings retained a deeper sense of emotional resonance and communal bonding that could not be replicated in virtual spaces. Another key finding relates to leadership adaptation. Pastors and ministry teams were compelled to develop new forms of digital literacy, restructuring their roles to accommodate the demands of virtual ministry. This often meant delegating technical responsibilities to younger members with stronger digital skills and rethinking sermon delivery to resonate with audiences engaging through screens rather than pews. The shift also fostered greater spiritual accessibility and inclusion. Digital platforms broke down barriers that had long excluded certain groups from full participation in worship, particularly the elderly, disabled, and members of diaspora communities. For many, virtual ministry provided a new level of belonging and connection to faith communities. At the same time, the study highlights several challenges of digital ministry. Respondents frequently mentioned screen fatigue, the weakening of interpersonal bonds, and lingering theological concerns about the authenticity of virtual sacraments such as communion or baptism. These tensions underscore the ongoing negotiation between tradition and innovation in digital religious practice.

## Christianity, Islam and Traditional Religions Adoption of Social Media

Abusharif (2020) proposes a dual-framework—religious authority and mediatization theory to analyze digital Islam in Africa. The chapter emphasizes the transnational nature of Muslim digital practices and critiques Western-centric models, urging context-sensitive methodologies for African media-religion research. Sande (2021) examines how emerging technologies, particularly human enhancement tools, interact with African traditional religions, using the Shona concepts of *munhu* (personhood) and *unhu* (virtue). The study finds that both Shona spirituality and enhancement technologies aim to improve human life, but from distinct ethical standpoints. It concludes that technological advancement aligns with indigenous African values, though practiced differently. Campbell and Tsuria (2021) provide a systematic survey of how religious practices are reshaped by digital media across global faith traditions. The book highlights how digital platforms mediate religious authority, ritual, and identity, using empirical examples from Christianity, Islam, Judaism, Hinduism, and Buddhism.

In summary, Christianity has widely adopted social media for evangelism, community, and worship live streaming. Islam shows strong use of influencers and online authority negotiations, particularly among youth. Traditional religions, while slower in adoption, use social platforms for identity preservation, diaspora connections, and ritual adaptation. The comparative scholarship highlights how theology, authority, and cultural context shape distinct adoption patterns.

**Methodology** A mixed research approach was employed, using in-depth interviews as the primary data collection method. The study involved 40 participants, including religious leaders, technology experts, and community members from diverse religious backgrounds in North Central Nigeria. The sample was designed to capture a range of religious viewpoints, including perspectives from Christian, Islamic, and Indigenous beliefs. Data were analyzed thematically, focusing on identifying patterns that reveal how religious ideologies influence decisions around technological adoption and social development.

To ensure diversity in perspectives, participants were selected based on specific criteria, such as their roles within their religious communities, levels of engagement with technology, and experiences with social development initiatives. This criterion ensured that the insights gathered reflected not only individual beliefs but also the collective values and norms that shape community

attitudes toward technology. In the research process, ethical dilemmas often arise in relation to ensuring participant anonymity and mitigating research bias. Protecting participants' anonymity and confidentiality, researchers minimize the collection of identifying details, use coding systems instead of names, and implement secure data storage practices. Researchers also adopted triangulation, and peer review to promote transparency, fairness, and credulity in the study.

Data collection involved semi-structured interviews, which allowed for flexibility in exploring participants' thoughts and experiences while adhering to key research questions. Interview questions were designed to elicit detailed responses about participants' perceptions of technology, its implications for social development, and the role of religious ideology in influencing these perceptions. The interviews were conducted in a comfortable and confidential environment to encourage openness and candidness, facilitating a richer data set.

Data were analyzed thematically, with a focus on identifying patterns and themes that reveal how religious ideologies influence decisions around technological adoption and social development. This involved transcribing the interviews verbatim and employing a coding process to categorize responses into meaningful themes. The analysis was iterative, allowing for constant comparison and refinement of themes as new insights emerged.




Figure 2: Demographic distribution of respondents by religion and role

Figure 2 shows the distribution of respondents, the religious leaders interviewed were 5 Christians, 5 Muslims and 5 with indigenous religious affiliation. Three of the leaders selected were technology experts while 7 of the community members involved in the study were Muslims and Christians respectively. Only 2 of the community members are with indigenous affiliated religion.

## **Findings**

The study's findings indicate a strong connection between religious values and decision-making processes in areas impacted by technological advancement. Several key themes emerged:

- 1. **Ethics and Technological Adoption:** Many religious communities prioritize ethical considerations when approaching technology. Religious leaders emphasized the need for technologies that respect human dignity, privacy, and societal well-being, often discouraging technologies that are perceived to exploit or dehumanize individuals.
- 2. **Education and Religious Influence:** Religious ideologies shape educational content and influence acceptance of technology-driven learning methods. For instance, some religious groups support the use of technology in education, particularly when it promotes moral and ethical learning, while others view it cautiously, wary of content that may conflict with religious teachings.
- 3. **Governance and Policy Formation:** Religious values guide governance decisions, with religious leaders often advocating for policies that restrict technologies deemed morally compromising. This influence can result in both proactive and restrictive stances on technological progress within governance structures.
- 4. **Dual Role of Religion in Technology:** Religion acts as both a facilitator and a barrier to technological adoption. Progressive religious communities support innovation that aligns with ethical and moral principles, while conservative communities tend to approach new technologies with caution, sometimes leading to delayed adoption.

#### **Discussion**

The dual role of religion, acting as both a supporter and a barrier to technological progress, reflects its broader influence on social values and cultural practices. In contexts where religious teachings align with ethical technology use, there is potential for socially responsible innovation that prioritizes the well-being of the community. However, conservative interpretations can pose challenges to technology integration, particularly when religious principles are perceived as contradictory to technological advancements. This complexity underscores the need for frameworks that balance religious concerns with the demands of a technologically advancing society. The dual role of religion as both a supporter and a barrier to technological progress illustrates its significant influence on social values and cultural practices. In contexts where religious teachings align with ethical technology use, there is substantial potential for socially responsible innovation that prioritizes community well-being. For instance, religious institutions have historically leveraged technology to disseminate health information and education, as seen in various health initiatives in Africa that utilize mobile technology to improve maternal and child health outcomes (Ezeani, 2020). However, conservative interpretations of religious doctrine can present formidable challenges to technology integration, particularly when advancements are perceived as conflicting with established religious principles. For example, debates surrounding genetic engineering and artificial intelligence often invoke ethical concerns rooted in religious teachings, leading to resistance in communities where these technologies are viewed as threatening to traditional values (Pew Research Center, 2021).
