# The Religious Significance of Unity in Islam: Lessons for the Nigerian Muslims

# Abstract

Dwindling or lack of unity among Nigerian Muslims has become a serious matter for which a lasting solution is much needed urgently to avoid a complete breakup. It has gone to the extent that Muslims are no longer interested in offering prayers behind or with others. Islamic salutations are also limited to those who are familiar or are having affiliations such as Muslims in the same area, profession, or Islamic and other organisations. The argument is always based on flimsy and insignificant issues or complains without valid proof backing the action taken. Though politics, ethnicity and misunderstanding have been described as the stumbling block for Muslims' unity in Nigeria, lack of Islamic education, as regard the five pillars of Islam and its practices constitute the original threat to Muslims' unity. Consequently, unity is an antidote to security, peace and justice in every society. Unity is considered as fundamental for the consolidation of position for the religion and its adherents, the Muslims on the surface of earth. This paper draws attention to the present state of unity among Nigerian Muslims. It examines the concept of unity in Islam alongside its practice by Islamic predecessors and addresses unity issue based on its religious significance. It raises suggestions and concludes that Nigerian Muslims can be united if religious dictates on unity is practiced accordingly and history, which its essence is to learn from the past for correction of present situation and serve as lessons for the future generation, is followed in respect of Islamic required unity.

# Introduction

An insight into world environments and surroundings reveals a successful and a balanced nature emanating from the unity among the components concerned. For example, it is the cooperation between seconds and minutes that makes an hour, hours make a day, days become a week, weeks become a month, months become a year. Nights, days and seasons like raining and dry periods including stars, sun and moon, among others are also involved in these

developments. It is divine unity that makes them to produce desired results. This suggests harmony, justice, peace and security among these natures. Any disagreement among them will lead to disharmony, injustice, lack of peace and security, repercussion of which will affect the life of mankind.

Consequently, no human being can live successfully without a united cooperation with others. Originally, all men are equal in Islam irrespective of their colour, language, race and nationality. Their equality first rests on the religious fact that Allah is the God of all Who also sent Prophets and Messengers to them to remove all false barriers of race, colour, language and wealth Ahmad (nd.). Secondly, they are equal in terms of parental origin, nature and components. This implies that the unity of mankind starts from the unity of their Creator, Allah, then Adam and Ḥawā', the progenitors of mankind. Nature and components of men like feeling, sweating, emotion as well as anatomy, are of no differences. All these prove that there must be unity among mankind due to their equality. Likewise, the unity of Muslims is unique because it is a religious demand emanating from sincere brotherhood as mentioned in the Qur'an and *Hadīth* (prophetic tradition).

However, barriers such as race, status, wealth, colour, language, rivalry and so on have succeeded in creating disunity among men in general and Muslims in particular. Lack of unity has gone to the extent of causing wars among the generations of the world. It was in connection with this that some unsuccessful measures have been taken to create unity among mankind by various international and regional communities like the United Nations (UN), African Unity (AU) and so on (Buah 1975). With reference to Islam and Muslims in Nigeria, it is well noticed that the crack on the wall of the Nigerian Muslims continues to widen every day. This is readable in the social media, national dailies and even reflects physically in the relationship between Muslims in the North and Muslims in the South. The creation of tribal associations otherwise called socio-cultural groups in regions also compounded the issue of disunity among Nigerian Muslims. The main objective of this study is to determine the drivers of disunity with a view to identify fundamental causes of disunity and proffer solutions accordingly. Unity of Nigerian Muslims is needed and achievable when it is based on Islamic faith, education with its practice.

#### **Conceptual Framework**

Unity of the Muslim community is not limited to religious commands alone, it has to do with obedience to Allah and His Apostle (SAW) since Islam is a complete submission to the will of Allah. Once somebody declares himself a Muslim, then he has to follow the commands of Allah and His Messenger (SAW) (Ahmad nd.). Therefore, Allah has commanded the Muslims to hold fast to His religion in unity without division, 'and hold fast, all together, by the rope of Allah and be not divided among yourselves', (Qur'an 3 verse 103). According to Ibn Kathīr, the rope of Allah as mentioned in this verse is the Holy Qur'an, tradition of the Prophet (SAW) and the covenant taken to worship Allah alone. This means that the strength of Muslims rests on their unity in obeying Allah and His Messenger (SAW), 'and obey Allah and His Messenger, and do not dispute (with one another) lest you lose courage and your strength departs, and be patient', (Qur'an 8 verse 46). Unity and cooperation are among the basic principles of Islam while every aspect of command or prohibition also indicates unity in Islam (islamqa.info>answers>....).

Imam Hasan al-Bana has spoken well concerning the unity of the Muslims when treating the institution of brotherhood in Islam. According to him, fastening of the heart and souls of Muslims together with the bond of faith is called brotherhood. Faith is also the strongest and most precious of all bonds. Brotherhood is the companion of faith while division is the companion of disbelief. The original strength is the strength of unity and there is no unity without love. While the least degree of love is the soundness of the heart, its highest is giving preference to other brother's interest over oneself. A truthful brother will consider his brother's interest before himself because he can never be among the group other than that of the believers since wolf preys only on the sheep which separates itself from the flock. A believer to a believer is like a building which one part supports the other.

## Importance and Basis of Unity in Islam

There are several verses of the Holy Qur'an and texts of *hadīth* (Prophetic traditions) which educate or command Muslim unity. Qur'an and *hadīth* are the basis for the unity and harmony of Muslims as said by the Prophet (SAW) that 'I am going to leave two things for you; the Book of Allah and my *sunnah* (tradition). You will not be misled as long as you hold them tightly (Maqbool 2015). There is no doubt that the Prophet (SAW) and his companions demonstrated the real meaning of unity as requested by Allah. Muslims are one single

community who are commanded to unite in the highest service of Allah as contained in Qur'an 21 verse 92, 'Surely, this community of yours is a single community and I am your Lord, therefore serve Me (and no other)'. Equally, Islam means a state of peace through submission to the will of Allah. As such a Muslim earns that peace because of his submission to the will of Allah. This means that Muslims lack submission or the submission is weak in quality when there is no peace among them. Allah warns the Muslims to fear Him and keep straight the relations between them as He also asks them to obey Him and His Messenger, if they believe truly (Qur'an 8 verse 1). Muslims are informed by Allah that disunity is based on loss of love which leads to breed of weakness among Muslims (dawahnigeria.co...creed/basis-unity-islam).

In order to unite, there is need for patient and perseverance, 'and obey Allah and His Messenger, and fall not into disputes, lest you lose heart and your power depart' and be patient and persevering...' (Qur'an 8 verse 46). The unity in the mode of worship is important just as the unity of Muslims because both man and jinn are commanded to worship Allah (Qur'an 51 verse 56). This means that the reason for man's existence is the same. The Creator, Allah is One, the Messengers preached one and same religion, the *giblah* direction is one, the five pillars of Islam like performance of prayer, payment of zakah, fasting during Ramadan and the institution of pilgrimage Muslim (hajj) serve as basis for unity (www.markedbyteachers.com>gcse>dis....). It is on the basis of Muslim unity in worship that Muslims are called the best community, (Qur'an 3 verse 110). Unity is more enhanced if the duties of brotherhood are sincerely observed. According to the Prophet (SAW), 'the believers are like a single body. If eye complains, the whole body also complains and if head complains the whole body complains'. This is corroborated in the Qur'an 9 verse 71 where Allah says, 'the believers, men and women, are protectors, one of another: they enjoin what is just and forbid what is evil: they observe regular prayers, pay zakah and obey Allah and His Messenger. On them Allah pour His mercy: for Allah is Exalted in power, Wise'.

#### **Conflict Resolution as a Means of Unity**

In every given society, disagreement is inevitable because it is a nature and challenge created with mankind. Islam therefore recommends some processes to regulate it so that the unity of Muslims remains firm. Qur'an 4 verse 59 directs the Muslims when disagreement occurs, 'O you who believe! Obey Allah and obey the Messenger, and those charged with authority

among you. If you differ in anything among yourselves, refer it to Allah and His Messenger, if you do believe in Allah and the Last Day: that is best, and most suitable for final determination'. When resolving issues, unity of Muslims should be considered first, this is why the aggrieved should be patient, accept the outcome of the judgment and stay with his brothers. It is on the record that Muslims do disagree among themselves in matters during the time of the Prophet (SAW) and this did not divide them at all. Example of this was when the Prophet ordered them to go to Banū Qurayẓah and told them that they should not allow the forenoon prayer (Asr) to meet them except at Banū Qurayẓah's place. They were on their way when the time of prayer arrived. Some companions believed that they should observe prayer while others believed that they would not perform prayer until they get to Banū Qurayẓah's place. Each one of them prayed according to his understanding of the Prophet's message. The Prophet did not disapprove any of the groups when they narrated the issue to him on their arrival (Al-Mubārakafūrī 2003).

Furthermore, there was a man who grew up in the era of ignorance. This man was jealous of the Muslims in his heart. He hired a Jewish youngster to create a conflict between Hawz and Khazraj, the two major tribes in Madinah. He instigated them for clash and conflict by reminding them of the wars between them before Islam. The tribes were ready to resume fight with each other. The incident was reported to the Prophet who rushed to the site with some companions. On getting to the site, he said, 'O Muslim! Have you forgotten Allah by starting to improve the symbol of ignorance while I am still in your midst...? Allah raised your status by the light of Islam, abolished ignorance, developed affection and fraternity among you. Do you want to go back to the state of disbelief?' Because of this warning, the parties put their weapons down and embraced themselves in tears, then they departed to their homes in love (Maqbool 2015).

## Foundation of Unity in Islam

Islam started with the emergence of Prophet Muhammad (SAW) who called people to Islam. He immediately assigned the newly converted Muslims with the responsibility of calling others in the manner in which he called them. These people joined the Prophet (SAW) in preaching in an astonished manner because they realized the feelings of general responsibilities towards Islam and Muslims. The major topics of the preaching were initially based on oneness of Allah (*at-Tawhī*), belief in the Last Day, purification of soul and

entrustment of matters to Allah. Throughout the first three years, preaching was done secretly and few people who joined Islam were trained to be brothers who always assist one another. During the subsequent years in Makkah, Muslims were persecuted but they endured and exhibited the spirit of brotherhood and unity among themselves until they migrated to Madinah where they were able to consolidate their faith and develop their Islamic unity with their counterparts in Madinah. It is important to mention that there was severe adversary between the two tribes of Madinah, Hawz and Khazraj for decades. The adversary ceased immediately they got in touch with Islam in Makkah while unity among them became stronger thereafter (Al-Mubārakafūrī 2003).

Consequently, the first assignment carried out by the Prophet (SAW) in Madinah was the establishment of his mosque wherein the first Muslims were trained. The next step he took was fraternization between the Muslims from Makkah and Muslims in Madinah. The fraternization is unique in the history of brotherhood throughout the world. This is because the Muslims from Makkah were not made to feel like strangers by their host. Islamic government was formed with the Prophet as the Head of State, commander in chief and Imam. The Muslims displayed their sincere unity in support of Islam and in repelling every aggression from within or outside the city of Madinah. When victory came, people started trooping out to accept Islam in Madinah. It was power of the faith then unity accompanied by patience that made it possible for the first generation of Muslim to succeed (Mashhūr 2006).

## Unity after the Death of the Prophet (SAW)

The set of Muslims who took over the power after the death of the Prophet were people from Makkah. There was no dispute in selecting them as *khulafāu'r- Rasūl* (successors of the Messenger). This proves the strong faith of the people of Madinah who did not contest the leadership of these four people on nationality basis. It is worth mentioning that companions of the Prophet became governors of different provinces without considering their nationalities, race, colour, tribe or status. This confirms the sincerity of brotherhood of this generation. However, division among them started per se after the assassination of the third *Khalīf*, Uthman bn Affān (RA). The assassination was masterminded by the Jews and hypocrites who used the kindness and soft-mindedness of the *Khalīf* as an opportunity to dismantle the existing unity of the Muslims. The Muslims became divided into four groups with different ideologies since that time (Ajani 2015).

## Division of the Muslims after the Prophet (SAW)

Divisions among the first generation of Muslims occurred as a result of failure to identify common enemies of Islam and hypocrites among them. The enemies of Islam, especially the Jews know that the weakness of the Muslims lies in their disunity; that was why they engaged in every means of conspiracy to dislodge the Muslim community. The plan to cause problems among the Muslims started during the time of the Prophet. It also continued during the reigns of Abubakr and Umar. It only became practical at the tail end of Uthman's reign. This scenario was planned and spearheaded by Abdullah bn Saba', a Yemenite Jew who had accepted Islam for selfish interest and to destroy the peace of the Islamic state. He could not do it alone, so he tricked some Muslims and got their support. He fabricated and executed many evil plans with them. He did this by inciting people to forge complains against the governors of Islamic provinces, government officers and the Khalīf himself as well as calling the Muslim leaders irreligious, non-practical and bad Muslims. He also forged letters and sent them to places. The letters indicated lack of justice and peace in the places from where they were sent and that some leading companions were not in support of the Khalīf. When the Khalīf sent a letter to Egypt that the Egyptians should accept Muhammad bn Abubakr as their governor, Ibn Saba' changed the content of the letter to read 'kill' Muhammad bn Abubakr. The word used in the letter is *iqbil* (accept) but he double-crossed the letter and changed the word to 'uqtul' (kill). This letter generated anger from people and he got more supporters. The result of the insurgency led by Abdullah bn Saba' was the assassination of the Khalīf. Madinah remained without government for three days after the assassination of the Khalīf. However, Ali bn Abī Ţālib after consideration, took over as the next Khalīf. But it was not easy for him because the Muslims had become divided into parts. A group demanded that he should find out those who killed 'Uthman, bring them to book before he could be accepted as Khalīf. This process led to divisions of Muslims into four groups, namely; 'Uthmānīs (people of Syria and Basra, supporters of the assassinated Khalīf, they were led by Muhawiyyah, (a governor appointed by 'Uthman), Shī'aAlli, (supporters of Alli), Murhibūn (soldiers on the battle field at the time of 'Uthman's assassination), Ahlus-sunnahwal-jamā ah (those who were neutral in their opinions as regard Ali and Uthman, they considered two of them righteous people). Khawarij came to be during the time of arbitration. They were initially supporters of Alli but became opposition when Alli agreed to the arbitration. The lands of Islam could not be held together thereafter (Ajani 2015).

# An Overview of Nigerian Muslims' Unity

Though differences and disagreements are natural and deeply rooted in man but should be guided by Islamic principles based on faith and *Sharī'ah* (Islamic Law). It should also be mentioned that in this present world, human relations are interrelated and complex with numerous ideologies and technological advancement has made the world closer and smaller than ever, a situation that makes the Muslims being absorbed Al-Qaradāwī (1991). This has to do with the fact that the environment has great power to influence people and make them adhere to prevailing attitude, belief, culture and behavior of the people around them. But the Muslims can defer and disagree and yet remain brothers who love and respect each other and refrain from exchanging accusations despite the situation in which they found themselves. Here are few instances of threat to Nigerian Muslims' unity:

Weakness of Aqīdah

Islam is a complete way of life with all its comprehensive legislations but which are almost lacking in its adherents. 'Aqīdah (belief, faith or creed) is the foundation of Islam. It is based on the statement of testimony which implies sincere belief in and professing faith in the Oneness of God and the prophethood of Muhammad (SAW). It is this statement that unites every Muslim irrespective of nationality, language, status, etc. The statement is concealed in the heart, pronounced by the tongue and practiced by the limbs of the body. The statement is comprehensive and therefore needed to be studied, practiced and spread among the people by every Muslim claiming Islam (Zarabozo, 2003). For example, love and hate which are agents of unity and disunity respectively should be for the sake of Allah. Likewise, loyalty and disloyalty should also be for the sake of Allah. It is religiously required of a Muslim to love, hate, please or displease for Allah sake. The soundness of 'Aqīdah determines the soundness of an action because such action is for the sake of Allah and it is rewarded accordingly. The level of Nigerian Muslims' faith according to their attitudinal behavior in the aspects such as belief in Allah and the Prophet (SAW), relationship with fellow Muslims or non-Muslims, acts of worship is suspicious and therefore affect the unity which Allah prescribed in the Qur'an 3verse 103. Unity of the Muslims is founded on unshakable belief in Allah and His Oneness otherwise called Tawhīd because Allah, the worshipped, is One and Universal; therefore, unity is required of the worship and worshippers. This should be imparted in the hearts of Muslims as believers.

According to Adetona (2013), *Shirk* (idolatry, paganism and polytheism) is the opposite of ' $Aq\bar{i}dah$  and the act of ascribing plurality to Allah, an act of associating partnership with Allah. *Shirk* is divided into three according to Islamic scholars. These are major *Shirk*, minor *Shirk* and inconspicuous *Shirk*, each of which affects the ' $Aq\bar{i}dah$  and religion of its adherents to some extent. It is a fact that Muslims are involved in some of these types of *Shirk* to the extent that there are societies such as Chrislam and Chrislamherb which implies the adherents of Islam and Christianity and adherents of both religions and traditional religion respectively in our contemporary society. Some Muslims are members of secret cults, free masory as they partake in some traditional rites like *Oro ile*. The involvement in any of these acts by Muslims is a denial of Allah of His lordship right, unity and unity of mankind and Muslims specifically. This proves that the base, *tawhīd*, is no longer holding.

Faith which is the foundation of religion is ineffective today. This is because, unlike the Companions of the Prophet (SAW), the present Nigerian Muslims give preference to learning the scripture to learning of the faith and its practice Zarabozo (2003). The existence of long paper presentations on various Islamic issues with fascinating subjects, topics, stories and contributions by Muslim scholars of different fields is a manifestation of learning of scripture without giving consideration to learning of faith. This is because the contents of the papers presented are not been put into practice by the writers or the readers, hence, no impact on the society. The longest verse of the Holy Qur'an is just a page while the longest text of *Hadīth* is likely not more than a page also. The implication of this is that the action of the Prophet (SAW) and his Companions enticed people to Islam if compared with their admonitions, sermons and papers which are very short. Accordingly, the soundness of faith of a preacher determines the acceptance of what he preaches by the listeners and manners to which what he preaches penetrates into the heart of the listeners. In order to be firmly united, Muslims have to study and practice *tawhīd* first before any other thing.

## Mosque as a Threat to Muslims' Unity

The importance of the mosque to the unity of Muslims is yet to be realized by Nigerian Muslims. It is on record that the first generation of Muslim was trained in the mosque of the Prophet (SAW). They were taught  $tawh\bar{t}d$  as well as the Qur'an, the tradition of the Prophet and they practiced the religion whole-heartedly to the extent that they became the best generation of mankind. The companions always made themselves available in the mosque

with their teacher, either during prayer times or leisure times. During prayers, they form straight and well knitted lines with presence of their hearts. They believed in the mosque as an origin of unity among Muslims. Today, mosques have been deserted by many of the contemporary Nigerian Muslims. This is based on the account of the Muslim's population in a given society comparable with those who normally attend mosques for prayer. Even those who attend the mosque do not arrange the files (*sufuf*) properly, failing to realize unity spirit infused in the mosque and file formation. It is reported that the Prophet (SAW), used to turn to face the congregation and say 'straighten your row (three times), for by Allah either you straighten your rows or Allah will create division among your hearts'. An-Nu'mā bn Bashīr who related this report said that he saw men standing shoulder to shoulder, knee to knee, ankle to ankle. There is no doubt that mosque and row formed in it for prayer (*salah*) constitute a means of unity among Muslims (Abū Dāwud 2011).

Unfortunately, enmity starts from the mosque today because of trivial issues among the Muslims. For example, issue of keeping funds generated in the mosque in the bank or with the mosque treasurer caused an unprecedented crisis among some Muslims in a mosque to the extent that the Muslims in such area have divided into parts. The issue escalated and became a community discussion, the treasurer's character became questionable and he was labeled 'thief' while those who supported keeping the money with the treasurer including the Imam were also subjected to ridicule in the community. The Muslims have become 'you think they are united, but their hearts are divided' (Qur'an 59 verse 14). The more mosques are founded, the more the division among contemporary Muslims. Oja'ba Central mosque in Ibadan was the only place where majority of Ibadan Muslims used to observe their Friday prayers before. The exit of Shaykh Abdus-Salam Bamidele of Zumuratul-Mu'min and Shaykh UthmanYusuf Akanbi Lanase because of some misunderstandings with the then local scholars marked the beginning of disintegration in the central mosque (Shaykh Murtada Abubakr 2017). Two of them formed their own congregations respectively and this gave birth to free formation of different mosques with different Imams with different ideologies. The unity that concentrated in one place became scattered among various central mosques whose leaders were preferred by their followers to the general and recognised Chief Imam in terms of ideology and command. Allah says: 'They cut off their affair of unity and formed themselves into parties; with each party rejoices in that which it is holding' (Qur'an 23 verse 53).

#### Five pillars of Islam and Threat to Unity

The abysmal absence of  $tawh\bar{\iota}d$  leads to the inattentive and or negligence of the Muslims in core religious duties. The five daily prayers as basic act of social discipline are no longer offered properly with its requirements and conditions. Prayer contains statements and actions from the beginning to the end. It starts from the statement which confirms Allah as the Great and ends with the salutation which connotes peace. The question here is that is there any peace among Nigerian Muslims who have divided themselves in their various mosques and communities due to trivial issues or misunderstandings? The absence of peace which is a factual evidence of disunity testifies the presence of shameful and evil deeds among the Muslims whereas this negates the aims and objectives of offering prayer which Allah says it prevents Muslims from shameful and evil deeds (Qur'an 29 verse 45).

Closely related to this is the issue of  $Zak\bar{a}h$  (Compulsory due) which is not paid by majority of the rich Muslims in Nigeria. This has reduced brotherhood love expected to be between the rich, who pays it and the poor, who receives it. It is believed that every heart loves money and wants to receive but hardly like to give. This is why payment of  $Zak\bar{a}h$  reveals the truthfulness of the faith of the one who gives it (Al-'Uthaymīn 2003). Instead of paying this legal due, majority of rich Muslims prefer giving *şadaqah* (voluntary almsgiving), especially to show off. Some of them consider  $Zak\bar{a}h$  unnecessary since amount they give out as *şadaqah* is more than the amount payable on  $Zak\bar{a}h$ . These people fail to realize the obligatory nature of  $Zak\bar{a}h$  and its conditions. It is a fact that through the institution of  $Zak\bar{a}h$  the Muslim community in Nigeria can become a single family in which the strong helps the weak, and the rich helps the poor because the rich believes he has brothers to whom he has to be generous in the manner in which Allah is generous to him. If  $Zak\bar{a}h$  is properly administered, revolution of the poor against the rich and community, financial crime, robbery, stealing and other evil acts will be prevented; hence, a peaceful and united community.

The extent to which the Muslim community in Nigeria is being threatened by unnecessary disputes due to sighting of moon for the commencement and termination of Ramadan fasting and the announcement of Islamic festivals' days ( $\bar{I}dul-adh\bar{a}$  and  $\bar{I}dul-fitr$ ) is hardly determined. The *Sultān* of Sokoto, is the leader of Muslims in Nigeria and is also the President-General of the Nigerian Supreme Council for Islamic Affairs (NSCIA). He is responsible for the announcement of sighting of the moon for the commencement and

termination of Ramadan fasting and commemoration of the two festivals of the Muslims mentioned above. He should also be notified of the sighting of moon in any part of Nigeria so that he would order Muslims in Nigeria to commence or terminate the Ramadan fasting or to observe any of the two festivals. Objection of the Muslims to the announcements of the *Sultān* started when some Muslims, especially from the Southern part of Nigeria discovered what they termed as ambiguity moon sighting as always announced by the *Sultān*. They claim that the announcements of the *Sultān* always contradict those of Saudi Arabia and other Muslim world. It was also discovered that Nigerian Muslims do observe twenty nine days fasting whereas it should be between twenty nine and thirty days as in the case of Saudi Arabia and some parts of the Muslim world. They also argued that why is it that it is only in the North that the moon is always sighted?

It was because of these reasons and others that the Southern Muslims founded the League of Imams and Alfas in late 1973 under the chairmanship of the then Chief Imam of Ibadan, Shaykh Muili Abdullah Basunu (d.1982) and Shaykh Adama Abdullah al-Ilori (d.1992) as the secretary. The League handles the issue of the moon sighting and other religious matters in the Southern part of Nigeria (Adegoke 2013). Aside this, there are other neutral Muslims who neither support the North nor the South on the issue of moon sighting; they measure between the duo. For example, they commence or terminate fasting if the announcements of the *Sultān* tally with the announcements from other parts of the Islamic world. Ramadan that is supposed to be a source of peace, harmony, and mercy emanating from the fear of Allah has become a threat to Nigerian Muslims' unity. It is even funny that Muslims complain about selection of the Chairman, Nigeria Hajj Commission. Their demand is that there are other Muslims from other parts of the country who are also qualified to hold the Chairmanship position of the Commission.

## Manifested Causes of Division among Nigerian Muslims

Unity has no border in Islam, it is international. It is realized when it is nourished and fostered by Islam. Qur'an informs that the Muslims are the best community ever raised because they enforce what is right, fight what is wrong and believe in Allah (Qur'an 3 verse 110). Where is that best Muslim community with all these attributes in Nigeria today? The community which does not consider  $tawh\bar{t}d$  in its activities and does not practice Islam that ascribes those

qualities to it. Politics and tribalism are the major causes of divisions among Muslims in Nigeria.

## **Political Contributions to Muslims' Division**

Nigeria, like other countries is geographically demarcated into segments like wards, local government areas, states and geo-political zones. Basically, there is nothing wrong in these divisions carried out for easy administration. It is an act of ignorance on the part of Muslims to divide themselves based on these national divisions. The Prophet (SAW) placed the newly converted Muslims of Madinah under twelve captains (*Nuqabā'*) to administer the affairs of their people in Madinah before he joined them later. He even took oath of allegiance from them during the second allegiance of 'Aqabah (Al-Mubārakafūrī 2003). It is observed that the more the country is divided into units for political or administrative reasons, the more the divisions among Muslims in Nigeria because everybody prefers to be identified with the zone or unit under which he falls to the spirit of Islam which considers every Muslim as a brother of the other Muslim irrespective of zone or unit from which he belongs. What compounded these divisions is the formation of political parties and the freedom to associate with or to disassociate from political parties. Currently, there are ninety one (91) dully registered political parties under the Independent National Electoral Commission (INEC) in Nigeria (https://www.inecnigeria.org>political-pa...)

These political parties have manifestos and motto which entice Muslims to join them. The manifestos contain some policies and ideologies of the party. The Muslims have been hitherto divided based on the beliefs of these political parties as it is reflected in some social media where political parties exchange various hate speeches capable of causing secession in the country. Muslims are also involved in these abnormalities since most of them love their political parties and are ready to defend them with whatever means. They have forgotten the religion which mandates them to be brotherly with their fellow Muslims. They prefer the manifesto of their political parties to Islam because of the fear of expulsion from the party should they contradict the party's manifesto, forgetting that they can also be apostatized for contradicting most of the commandments of Allah concerning their unislamic activities in their various political parties. When complaining against the bad activities going on in political parties, a conscious politician remarked that adultery or fornication is considered a least sin by politicians. Not only this, the politicians do not see any big deal in killing their

opponents whom they considered as stumbling blocks without considering the religion as they also take themselves on oath using materials such as cutlass, gun, and so on, in order to keep secret of their bad deeds. Which of these acts is commanded by Islam? Islam will never command abomination or evil. Allah commands justice, good deeds, and giving to kith and kin, and He forbids indecent deeds, evil and rebellion of politicians (Qur'an 16, verse 90). The idea of ruling and opposition parties confirms the divisions among Muslims because both parties consist of Muslims and non-Muslims where each opposing one another without genuine cause most of the time. The Muslims and non-Muslims in a particular party are more united and are ready to cause problems for their fellow beings in other parties.

#### **Tribal Associations' Contributions to Muslims' Division**

Formation of socio-cultural organizations like Arewa Consultative Forum (ACF) in the North, Afenifere in the South-West, Ohanaeze Ndigbo in the East, Urhobo Progressive Union in the South-South, is also a testimony to the disunity of Muslims in Nigeria. Apart from these apex socio-cultural groups, there are other subordinate or militant groups attached to each one of them or operate independently. These tribal associations have grown to producing preachers of hate and purveyors of prejudice in which Muslims across the nation are also affected. There are Muslims as members in each of these tribal associations, fighting against other regions without consideration for Muslims in the opposite regions. Each of these associations supports its people whether they are right or not, oppressed or oppressors. Membership of these associations is based on ethnicity, birth place, citizenship, school of thought or common interest. Tribalism indirectly engendered the Nigerian civil war and indirectly gave birth to the present idea of quota system and state of origin. It brought about the growth of national inequality and anger of perceived injustice. The use of 'us' and 'we' becomes an order of the day among Nigerians; Jerome Samson (2014) Muslims inclusive. Tribes look down upon one another. These result to crisis that affects innocent people. All these are rejected by Islam. The Messenger of Allah (SAW) said, 'He is not one of us who calls to tribalism, he is not one of us who fights for the sake of tribalism and he is not one of us who dies following the way of tribalism (Abu Dāwud 2011).

The danger posed by activities of the indigenous people of Biafra (IPOB) to the security of the nation and how the Federal government dealt with them is no more news. Reaction of the Coalition of Northern Youth Group is well known to the public as well. Muslims, whether

minority or not, are found in both groups. This is causing divisions among Muslims in Nigeria up till today. It must be reiterated that the politicians contribute to the escalation of divisions of the Nigerians generally for selfish reasons. They have succeeded in dividing the nation into classes, using religion and tribe as instruments. In reality, Nigeria is divided into two, namely the politicians, among whom are the Muslims and the rest who have been disunited by the former based on tribalism and religion.

# Ignorance, Blind Imitation and Takfir (Charge of Unbelief)

It is a fact that ignorance is a great disease. It is an act of ignorance that made some Muslims, especially the youth to seclude themselves from the community and settle in a remote bush or village with an illusion that it is the best option to make them perfect their religion. Only Allah knows how many seclusion camps have been created by these ignorant youth in Nigeria. The leaders of these camps go to these remote areas with their wives, children and their blind followers. They teach their followers what they believe is Islam and they come to the city to recruit some youth, males and females to join them in the bush. They have succeeded in separating Muslim youth from their families. They feed on vegetables and the farm products which they cultivate while they limit their medication to herbs and roots. They claim it is forbidden to eat any processed food and take pharmaceutical medicines as they deny themselves of using any manufactured material. They trek and also avoid ridding cars and buses. It is forbidden to use all these things since the Prophet (SAW) did not use them; therefore, abandoning them is an act of renouncing worldly materials preached by Islam. It is this belief that prompts them to call anybody who is not with them or engages in using any material similar to the aforementioned,  $k\bar{a}fir$  (unbeliever). It is this type of ideology that led to the creation of the deadly sect called Boko Haram. These youth will never salute or respond to salutation because according to their philosophy, every other person is an unbeliever. There are similar youth in various institutions of higher learning in Nigeria, preaching the same thing among the students. These students do not have respect for lecturers and school authority. They practice Islam based on their philosophy. They have also changed the administrative system of the Muslim Students' Association of Nigeria (MSSN) to what they belief should be Islamic administration. The worst part of it is that they conduct marriages among themselves without following Islamic rules on marriage. They have brainwashed the girls to believe that their parents are unbelievers and as such the fathers cannot stand as *waliy* (guide). They also

divorce these ladies at will. In short, these youth and those who join them seek for an unprecedented Islam and that is why what is considered Islam by the generality of Muslims is not Islam in their philosophy.

## Secularism as a Bane of Nigerian Muslim Unity

Secularism has no base in Islam since the philosophy behind secularism is to separate religion from all walks of life. Islamic Law (Sharī ah) consists of commandments set for religious and spiritual purposes. These have to do with the rules of faith and worship as well as rules and laws that have to do with administration and organisation of state, the government and the community, relations between individuals and their communities and so on. Secularism is been used to divert the attention of innocent Muslims. It may be accepted in other religions like Christianity or Judaism because they are devoid of a Sharī 'ah or a comprehensive way of life. Acceptance of secularism by the Muslim community means rejection of Islam as a comprehensive way of worship ('Ibādah) and legislation (Sharī'ah). Likewise, it is denial of the divine guidance and a rejection of Allah's injunction Audah (1978). In Nigeria, citizens have been made to know that democracy is superior to every religion and they have been governed so. Some Muslims also believe this assertion. Whenever there is conversation on a particular issue which has a place in Islam, the remark is that this is not a religious issue. Recently, a discussion concerning whether the Nigeria Defense Academy should stop giving admission to females or not is going on. The general opinion of people is that the Federal government being led by a Muslim wants to introduce Islamic religion to deny females of their right. The issue of  $hij\bar{a}b$  has caused a lot of religious hatred and agitations against female Muslim students using it. It is funny to mention that some Muslims do support non-Muslims, who object the use of  $hij\bar{a}b$ . The curricula designed in the schools are secular in nature.

# **Revival of Unity among Nigerian Muslims**

The core importance of unity is its relation with *Tawhīd* to which every Muslim should adhere as a member of Muslim community. One is recognized as a member of a community only when he believes in such community. Therefore, the first identity of a Muslim is the statement of testimony which confirms the Oneness of Allah and the messengership of Muhammad (SAW). Alliance and solidarity between individual of Islamic community is based on the unity emanating from unity of Allah and imitation of His Prophet (SAW). Therefore, Muslims should learn and study this very important aspect of Islam and its core subject. It is the rope to

which every sincere Muslim should hold on. Allah commands this in the Holy Qur'an 3 verse 103 and He warns those who make division of an awful torment in verse 104. Dispute as one of the agents of disunity brings about laxity in courage and strength (Qur'an 8:46). Allah also attaches victory of Muslims to their belief. He says: 'so do not become weak (against your enemy), nor be sad, and you will be superior (in victory) if you are indeed (true) believers' (Qur'an 3 verse 139). This verse reveals 'faith' as condition for Muslims' victory. The impact of faith on the victories of the first generation of Muslim community in their engagements with the unbelievers and subsequent developments cannot be overemphasized. Therefore a nation without faith will not develop because its citizens will tread the part of impiety in all walks of life (Oyewole 2002).

Closely related to the above is the common issue of the Muslims which is Allah symbolized by the religion which commands unity among its adherents. Therefore, Allah is the Muslim's goal, the Messenger is their exemplary, Qur'an is the constitution, strive in the cause of Allah and dying in His cause is their path Al-Banna (nd). Every legislated act of religion like belief, regular prayer, fasting, zakah, keeping relations, etc. are common issues among the Muslims which can earn them the desired unity (Maqbool 2015). Consequently, Muslims should avoid labeling a Muslim or a group of Muslims irreligious because it is an innovation and a strange attitude introduced to Islam by some ignorant or enemies of Islam. Once somebody professes the statement of testimony, such person's blood, wealth and dignity are safe. Those who charge fellow Muslims and call them bad names have no factual evidence. Takfir is a tool used to gain personal interest on the basis of envy, hatred and prejudices. Those who use Takfir for Muslims are copying the Khawārij who introduced it in the history of Islam (Maqbool 2015). Takfir cannot breed anything except disputes, hatred and intolerance. Some youth who are known with this do not attend mosques and they do not mix with other Muslims. In fact, they engage in sinful activities and they will not cooperate with other Muslims. This attitude has to be stopped. Muslim scholars and leaders should find ways to suppress this movement otherwise the unity of Muslims is at stake.

Consequently, spread of statement of salutation among Muslims plays an important role in creating peace in order to have a balanced society. This is why the words 'peace' and 'Islam' are derived from the same root and may be considered synonymous. *As-Salām* which means peace is one of the names of Allah. The last statements of daily prayers which indicate

termination of prayer are words of peace; likewise every time salutations of Muslims are expressions of peace. If the concept of peace is judiciously used among Nigerian Muslims, there will be unity among them because of secret infused in this word. The prophet (SAW) urges us to always say the statement of peace always Abdalati (nd.). Abū Dāwud related that the Messenger of Allah (SAW) said, 'I swear by He who holds my soul, you will not enter Paradise until you have faith, and you can never possess faith until you love yourselves. Let me lead you to something that if you do it, you will love one another. That is spread *taslīm* (statements of salutation) among yourselves Abū Riyyah (2010). Today, some Muslims ignore this good deed either intentionally or because of lack of Islamic knowledge. These types of people lose some rewards and what can enhance unity among Nigerian Muslims. Peace is a symbol of unity of the Muslims.

Of importance to the unity issue is Muslims' adherence to Islamic Brotherhood teachings which places every Muslim as a brother to another Muslim, not only in Nigeria but throughout the world. This is a blessing and favour from Allah on the Muslims Badmus (2001). The method of the Prophet in teaching brotherhood is that he first anchored aqīdah into the minds of believers and trained them on the scripture practically right from Makkah and in Madinah. Therefore, believing men and women who were overwhelmed by aqīdah which dominated their sensations and psychic forces and became everything in their life graduated from his school. He then fraternized and organised them and took covenant and promise from them to practise and defend the religion. This brought about power of unity which assisted them to triumph over their enemies and problems Mashhur (2006). Among actions which aid brotherhood and unity is that Muslims should form the habits of praying for Muslims in absence, make visits, respect and honour invitations, love them, be cheerful when meeting them, donate or give gifts to them, be sympathetic with them during sorrow or problem and rejoice with them when they feel happy. Muslim should be concerned about other Muslim's problems because of the statement of the Prophet (SAW), 'he who does not have concern for the affairs of Muslims is not among them' (Mashhur 2006).

It is very difficult to fight when enemy is not identified therefore, it is important for Muslims to identify their common enemies that threating their unity. The common enemies of Muslims are the threats posed to them by politics, economics and culture. It should be recognized that Islam is a way of life, and it has paths laid down for every action or engagement. Muslims

should be aware that enmities and hatred created by contemporary political or economic activities are not teachings of Islam, which emphasizes justice, sincerity and fair play in these activities and others. Accordingly, no mature Muslim should engage in any activity until he studies and knows Islamic rules on it. (Al-'Uthaymīn 2003). Politics has become a trade and a means of getting rich illegally. Politicians and government officials are used to luxurious life style and they live above their legitimate incomes Hassan (2010). They do not consider that they have denied the majority of poor Nigerians their right and that Allah will ask them the sources of their wealth. It is unfortunate that Muslims are also involved in this corruption. How then would they get the support of their fellow Muslims or unite with them? Surely politicians have caused great disunity among the Muslims by classing themselves and discriminating against Muslims. A Muslim politician is more cooperative with his copoliticians of other religion and is ready to support them on any issue even if such issue will affect the Muslims of opposing parties and Islam.

Muslim leaders and Islamic organisations also have greater roles to play in order to introduce unity among the Muslims. Working towards awareness of importance of unity is inevitable because disunity is affecting Nigerian Muslims negatively. The Nigerian Supreme Council for Islamic Affairs (NSCIA) should take a lead. Others like Muslim Ummah of South Western Nigeria (MUSWEN), Jamā'ah Naşrul-Islam and other local organisations including Arabic and Islamic schools should follow. One of the expected roles to be played is that they have to penetrate the government and its agencies in charge of media to promote the Islamic mode of Unity and make sure that all words of hatred, religious prejudices, blackmailing are not propagated. These leaders can make use of the Muslim professionals to serve as checks and balances for social and on-line media because of their printable comments on Islam. Sermons and preaching should be judiciously checkmated. There is need also to work on educational syllabi and curricula which almost exclude Islamic teachings on character building. The proprietors of Muslim schools should be persuaded to integrate Islamic thought of unity and related topics in their school lessons.

Commandment of goodness and forbiddance of evil is inevitable for reviving and sustaining unity among Muslims and it is the basis upon which Muslims are described as the best community (Quran 3 verse 110). Goodness earns its doer a reward while evil earns its doer a punishment. For this reason, a Muslim should try to be patient and tolerant with others and

avoid displeasing or offending others. This is because it is better for him to offend Allah directly than to offend a fellow man. Allah forgives every sin provided one repents on time by observing the conditions of repentance which are; to regret one's shortcoming, seek for forgiveness from Allah and decision not to engage in such sin. The fourth one is in connection with the oppressed. It is a required condition to approach the oppressed and declare an injustice done to him. If he forgives, then Allah also forgives, otherwise the settlement is deferred till the Day of Judgment when Allah will retaliate for him accordingly. It is believed that unity will exist among the Muslim community if there is understanding of evil of oppression.

#### **Lessons for Nigerian Muslims**

Victory is sure when people are united while failure and defeat are results of disunity. Muslims in Nigeria can only overcome the problems facing them through total obedience to Allah and His Apostle (SAW). This should reflect in the faith and other pillars of Islam accordingly. Prayer (salāt), compulsory due (zakat), fasting during the month of Ramadān and pilgrimage to Makkah should be observed in the manners in which they were performed by the Prophet (SAW). These pillars of Islam contain some spiritual tendencies capable of bringing about unity and its agents like love, brotherhood and cooperation, for Nigerian Muslims, if they are observed in accordance with their conditions and good intention. Unity of Nigerian Muslims should base on unity of Allah other than tribalism or any affiliation as it reflects in the situations with the Arabs today, who believe in Arab community rather than Muslim community. Today, it is observed that Arabs are not peaceful and are being humiliated from time to time due to their belief in Arabs unity (qawmiyyah) rather than Muslim unity (Islāmiyyah).Cooperation and brotherhood displayed by the people of Madinah to the Emigrants from Makkah which resulted to an unprecedented unity of the first generation of the Muslim community is a good lesson for Nigerian Muslims. Allah says: "...and give them (Emigrants) preference over themselves, even though they were in need of that..." (Qur'an 59:9). Sense of togetherness and fellow-feeling of Ash'ariyūn, a tribe in Madinah with whom the Prophet (SAW) created social or emotional tie because of its feelings towards the members of the tribe. The Prophet (SAW) said: "When the Ash'ariyūn are confronted with scarcity (of food) in the Jihād or when they are at home in Madinah, they collect all the provisions they possess in a sheet and then divided it equally among themselves. They are of

me and I am of them" (Al-Bukhārī). The action of this tribe shows the highest degree of unity among its members, a situation that attracted the Prophet (SAW) to claim his association and affiliation to them.

# Conclusion

The above submissions expose disunity among Nigerian Muslims and the factors responsible for such. The major factor is the weakness of their belief and practice of core Islamic mode of worship which possess some spirit capable of uniting them. Al-Mighty Allah knows His creature; that is why it impossible for them to live in peace because of the free will created with them. That is, why He laid down commandments capable of restructuring them to fulfil the purpose for which they were created. Therefore, among the aims and objectives of Islamic law is to facilitate the peaceful co-existence of man in general. The foundation of these commandments is faith in Allah and His Messenger which should reflect in other major modes of worship and social relation as well. Islamic concept of  $tawh\bar{t}d$  is the other name of the unity of Muslims and that is why Islam is the greatest unifying force in the world. As Muslims, it is high time we take advantage of Islam for a united Nigerian Muslims.

Various measures have been introduced by the world, continent, regional, national and local leaders to ensure a peaceful co-existence of people but to no avail. But it is a clear proof that Islam has laid down uncommon methods of unifying people. The Nigerian Muslims should not lose hope because Arabs were worse in character and were not united. But when Islam arrived, it changed their status from being ignorant to refined, godlessness to faithful, divided to united persons. It is hoped that Muslims in Nigeria can also be more united by taking a leave from prophetic lessons on unity. Lessons should also be learnt from what accounted for the disunity of the Muslims after the death of the Prophet (SAW). It was lack of trust in the leader, chance given to intruders and hypocrites among Muslims cum lack of investigation as regards the fake reports given by insurgents who established hatred of the leader in the minds of Muslims through their evil propaganda that always lead to disunity. Therefore, lessons drawn from this study can assist the Muslims in Nigeria in terms of unity formation, restoration and sustenance.
